

SHIPPED SEMEN STALLION SERVICE CONTRACT

This certifies _____, herein referred to as the Mare Owner, has engaged one breeding to: Yella Rockafella for the 2010 breeding season at \$350.00 for the following mare:

KMK Paint Horses, agent for the above named stallion will herein be referred to as Breeder. The service is engaged subject to the following:

1. This contract is good for one foal. Multiple foals from the same mare in the same breeding season will require a Separate contract and breeding fee for each resulting foal. The only exception to this would be twins that are carried Throughout term and foaled by one mare.
2. A non-refundable booking fee of \$100.00 from the above breeding fee is payable with this contract along with the first shipment fee of \$300.00. The balance of \$250.00 is due and payable within 10 days, once mare is confirmed in foal at 30 days post breeding. This 30 day vet check is required as part of this contract. If vet check procedure is not performed, Mare will be assumed in foal and all remaining fees are due within 10 days of the date the 30 day vet check would have been performed.
3. 1.5% per month will be charged for any fees not paid within that 10 day post 30 day vet check unless other agreement has been made, in writing and signed by both parties.
4. A photocopy of the registration papers with current owner or lessee listed on paperwork, shall be sent to the Breeder with this contract.
5. We highly recommend sending your mare to a vet clinic or breeding farm for her heat cycle. They will coordinate optimum shipping times with us. We will not be held responsible for any shipment that was not received by a vet clinic and administered by a certified vet or vet tech. We do guarantee to ship out semen that is at or above industry standards.
6. Wild Basin Ranch must be notified no later than 6pm Mountain Time on the day before the shipment is to be sent. If mare owner does not notify stallion station on the night before, there will be an additional 75.00 fee for stallion station to collect on short notice which will be due and payable regardless of pregnancy status on mare. **PLEASE NOTE: we can not guarantee same day shipping will be available so please schedule vet checks to coincide with terms of this contract!**
7. Shipped semen service charges will be as follows: (1) U.S. lower 48 states – shipped Federal Express Priority Overnight at \$300.00 per shipment (2) Canadian shipments – Federal Express \$ _____. Additional charge for Saturday Federal Express deliveries will be \$30.00. KMK Paint Horses and/or Wild Basin Ranch are not responsible for shipments once the container has left our hands. Shipments are sent out Mon, Wed and Fridays.
8. The breeding season in force for this contract shall begin February 7 and close April 15th of the year on this contract.
9. Live Foal Guarantee: Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if foal is stillborn a return season is guaranteed for the following year only, providing proper notification is given. Proper notification is a written certification by a licensed veterinarian within seven days that the mare has slipped, or produced a non-viable foal. Mare owner certifies that such abortion or death did not result from any act or omission of the Owner.
10. Should the above named stallion die, or become unfit for service, or if the above named mare should die during breeding season, then the Mare Owner may substitute another mare ..
11. A breeder's certificate will be issued to Mare Owner after all expenses have been paid in full and upon notification of birth of foal.
12. The signing of this contract entitles Breeder to charge 18% annual interest on all past due invoices. Past due billing is defined as those amounts not paid within 30 days of invoicing.
13. This contract is governed by the laws of the state of Nebraska. All accounts are due and payable in York County, Nebraska, in U.S. Dollars.
14. This contract is not valid unless completed in full. When Mare Owner signs and returns the contract and booking fee to Breeder, Breeder will notify Mare Owner within 10 days of approval. Upon notification, it will become a binding contract on both parties, subject to the above terms and conditions.
15. If there are any other arrangements or agreements, agreed to by both parties that alters any of the conditions above it shall be listed here _____

16. Once contract is accepted by stallion owner, you will receive phone numbers, addresses and other important information related to the breeding you have booked along with a copy of this contract with stallion owners signature.
